# RETAIN ORTHO, LLC PRIVACY POLICY

Retain Ortho, LLC (also referred to herein using "we," "our," and "us") is committed to protecting your privacy. We therefor provide this Privacy Policy to disclose our information collection, utilization, and sharing practices for this website. This Privacy Policy applies to any website that includes, displays, attaches, references, or links to this Privacy Policy (each the "Site"). Unless explicitly provided herein, this Privacy Policy does not apply to the practices of companies that Retain Ortho, LLC does not own or control or to people that Retain Ortho, LLC does not employ or manage. When you use and access our Site, you agree and consent to both the Terms of Use and this Privacy Policy. If you do not agree and consent to these terms, do not access the Site. The information we receive from you depends on what you do when you use this Site. Except as described in this policy, we do not sell, rent, share or disclose the personally identifiable information gathered on our Site to or with any other organizations. We reserve the right to contact you regarding changes to this Privacy Policy and other matters relevant to the Site.

Please note that this Privacy Policy is distinct from a Notice of Privacy Practices, which you may have received from your dentist or orthodontist. A Notice of Privacy Practices is a special notice required by a federal privacy law known as "the HIPAA Privacy Rule." In most cases, Retain Ortho, LLC is acting as a Business Associate of the dentist or orthodontist who invited you to subscribe to Retain Ortho, LLC and the information that your provides sends to us and that you provide directly to us is considered Protected Health Information or "PHI". We will safeguard your PHI in accordance with all applicable state and federal law, the terms of our agreement with your dentist or orthodontist and your provider's Notice of Privacy Practices.

### TYPE AND USES OF INFORMATION WE COLLECT FROM YOU:

Personally Identifiable Information ("PII") Some jurisdictions have expanded the common definition of PII to include things like internet protocol addresses, specific geolocation data, unique device identifiers, and other information that we may collect automatically, so you should review this Privacy Policy as a whole for a better understanding of our data collection, use, and sharing practices. At times, we may add forms or other options for you to communicate with us and provide us information about yourself. Unless otherwise indicated, the information we request is optional, but we may offer functionality on our Site that will not work properly without you providing the requested information, or you may not be able to obtain information we offer, such as requesting more information about our company and our products and services. ### INFORMATION AUTOMATICALLY COLLECTED:

Our Site may collect some information automatically. Some of the information we automatically collect is necessary for the proper functioning of the Site.
